

## APPLICATION FORM

You can make an application to the Data Controller, Eroğlu Garment Sc Zone "Eroğlu Garment" (the "Company") by using this application form available on our website.

### YOUR RIGHTS UNDER THE PERSONAL DATA PROTECTION LAW NO. 6698

**Under the Article 11 of the Personal Data Protection Law No. 6698, everyone is entitled to apply to the Company, acting as the data controller, regarding the exercise of the following rights:**

1. To know whether your personal data has been processed or not,
2. If your personal data has been processed, to ask for information about processing of such data,
3. To know the purpose of processing of personal data and to know whether such data is used in accordance with the purpose,
4. To know the third parties inland or abroad, to whom such personal data has been disclosed,
5. If the personal data has been processed incompletely or wrongly, to ask for correction of it,
6. To ask for deletion or disposal of personal data ex officio or upon the request of the data owner according to the conditions prescribed in the Article 7 of the Personal Data Protection Law No. 6698, after the reasons for processing of such personal data are no longer existing, although such personal data has been processed in accordance with the provisions of this Law and other relevant statutory requirements,
7. To ask for providing information to third parties, to whom such personal data has been disclosed, in connection with the operations conducted according to the Article 5 and 6,
8. To object to the occurrence of any negative results about data owner through analysis of the processed data exclusively by automatic systems,  
To ask for the indemnification of the loss suffered due to the processing of personal data in violation of the law.

### APPLICATION PROCEDURES AND RULES

Pursuant to the Article 13, Paragraph 1 of the Personal Data Protection Law and the Communiqué on the Procedures and Rules for Making Applications to the Data Controller as published in the Official Journal on March 10, 2018 under number 30356; the applications to be made to our Company as data controller regarding exercise of these rights must be submitted to us in writing or by using other methods determined by the Personal Data Protection Board (the "**Board**").

The personal data owner, also called as the "Relevant Person," may notify the Company about his/her rights and requests mentioned in the paragraph A. Accordingly, the relevant person may make a written application to exercise all his/her other rights pursuant to the Article 11 of the Personal Data Protection Law No. 6698 as follows:

- By personal application of the applicant,
- By post along with an enclosed declaration of signature,
- Through a notary public,
- With a secure electronic signature,
- By e-mail from the e-mail address previously notified by the relevant person to the data controller and registered in the system of the data controller.

The application must include the following information:

1. First name, last name and signature, if a written application is made,
2. Turkish identity number for citizens of the Republic of Türkiye; nationality, passport number or ID number, if any, for foreign citizens,
3. Domicile or workplace address to be used for legal notifications,
4. E-mail address, telephone and fax number, if any, to be used for legal notifications,
5. Subject of the request,
6. Information and documents related to the subject.
7. For written applications; the date on which the document is notified to the data controller or its representative will be deemed as application date.
8. For applications made by using other methods; the date on which the application is received by the data controller will be deemed as application date.

Applications will be finalized free of charge as soon as possible and within maximum thirty days depending on the nature of the request. However, if the process makes it necessary to incur additional costs, a fee determined by the Board in the Tariff may be charged.

Applications must be submitted personally. An application made on behalf of another person can only be submitted by presenting a power of attorney, provided that it contains authorization to ask for information within the scope of the Personal Data Protection Law. If the Company has suspicions about the identity of the applicant, it may request verification information from the relevant person.
